

Children in Nigeria are among those most at risk of flood disaster which threaten their Health Education and Protection.

## Effects of Conflict/Insecurity on Children




Insecurity in Nigeria has its impact on Children's Health, Education, Nutrition, Accommodation and Social Wellbeing



AIDS (UNICEF 2013); this represents 86 percent of the global burden of orphans due to AIDS.

Graph 1. Orphans in sub-Saharan Africa: A Critical Concern



orphans due to all causes in 2013, with 2.3 million orphans due to AIDS, as well as 450,000 children and 180,000 adolescents actually living with HIV (UNICEF 2013). One study ranks Nigeria's OVC burden higher than several countries facing war, such as Sudan, Somalia, Democratic Republic of the Congo, Libya, and Syria (Tagurum et al. 2015). One in every 10 households in the country is also estimated to be providing care for an orphan (Marsden and Miller 2011).
